AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

About the audit

This report contains the results of our independent accountability audit of the City of DuPont from January 1, 2018 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the year ended December 31, 2018, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement – purchases and cooperative purchases
- Cash receipting – timeliness and completeness of deposits, voids, and adjustments at community events and City Hall
- Fire Department – ambulance billings
- Use of restricted funds – building and land use permit fees
- Financial condition and fiscal sustainability
- Open public meetings – documentation of minutes

INFORMATION ABOUT THE CITY

The City of DuPont is located in southern Pierce County. The City has grown from approximately 980 residents in 1997 to over 9,385 residents in 2017. The City provides services including water, surface water, police, fire protection, parks and recreation services, land use management and development regulation, community services, street maintenance and construction.

The City is governed by a Mayor and seven Council Members. An appointed City Administrator oversees the City's 61 full-time employees and daily operations. For fiscal year 2018, the City operated on an annual budget of approximately \$15.5 million.
