Unaltered cats/dogs	\$60.00*
Spayed/neutered cats	\$12.00 (if a new pet license, documentation of surgery is required)
Spayed/neutered dogs	\$20.00 (if a new pet license, documentation of surgery is required)
Pet License replacement tag	\$ 5.00

*A dog or cat owner, presenting a written statement from a veterinarian that the spay/neuter surgery would be harmful, may purchase a license at the fee for neutered/spayed animals.

Dog or cat owners who fail to comply with pet licensing are subject to a civil fine of \$100.00.
